"2024" READINESS CHECKLIST

- If new, need cards showing Social Security Numbers and/or ITINs along with birth dates of all and proof of residency of dependents.
- Need ALL W-2's, 1099's, 1099-K's and 1098's: those for interest, dividends, investments, tax refunds, self-employment, sales, pensions, IRA rollovers, <u>unemployment</u>, Social Security, 1099-A, 1099-C, and any other income along with those showing mortgage interest paid.
- Need 1098-T's with the <u>financial transcript</u> from the college showing 2024 education expenses plus cost of books and needed equipment.
- IMPORTANT: Bring your last pay statement & your last pension statement - contains necessary information.
- 5. Any miscellaneous or other income and related expenses.
- Contributions to "Traditional" and "Roth" IRAs & Health Savings Accounts, plus 1099-SA for HSA distribution.
- 7. Payments for health insurance, RX insurance, and DDS insurance.
- Property tax statements for both summer and winter 2024 as well as information giving 2024 taxable value of personal residence.
- 9. Rent: Need name and address of landlord and amount of rent paid.
- 10. E-file: Need correct bank account number for direct deposit.
- 11. Need driver's license information for both taxpayer and spouse.
- 12. Bring your IRS IP PIN (Identity Protection) if you have received one.

AFFORDABLE HEALTH CARE (ACA) (Obamacare)

- You need to bring Form <u>1095-A</u> if you bought insurance through the <u>Marketplace</u>.
- CORPORATE TRANSPARENCY ACT/BOI-watch for extended due date. Must be filed @ FinCEN by all LLCs, Corporations, S-Corporations, HOAs, Charitable Organizations, any organizations registered with Michigan (LARA) or other state
- ▶ Please provide us with your email address if you have one. Will be used for appointment reminders.

- Copies of K-1's from partnerships, S Corporations, estates and trusts.
- Business mileage Bring start & end odometer readings for 2024 with business miles, interest paid on vehicle, & plates.
- Year-end statements showing transactions from mutual funds/brokerage accounts. Important: need all pages
- If you bought, sold or refinanced during the year, bring all closing statements.
- If have foreign bank or retirement accounts, bring 2024 statements.
- 18. If IRA transferred directly to church or charity, bring proof.
- Bring a record of the dates and amounts of any estimated tax payments made, and record of any other payments made.
- Information needed if had Qualified energy efficient items for your home: windows, doors, insulation, furnace, air conditioner, water heater and so forth.
